Dear Participants,

• In the recent decades, rapid economic growth and urbanization lead to a substantial increase in the demand for many and diversified economic activities such as mining and manufacturing, agriculture, transportation, etc. And, as a result, these sectors have caused very harmful impact on the environment, particularly in the developing world.

- Therefore, today the majority of developing countries are facing serious environmental challenges, including desertification, deforestation, air and water pollution, water scarcity, declining wildlife populations and loss of biodiversity.
- Representing a significant part of the developing world, the majority of OIC member countries are characterized by poor environmental performance and highly vulnerable to environmental changes induced by the increasing anthropogenic activities. The situation is particularly alarming in low income and least developed member countries due to their low mitigation and adaptation capacities coupled with high vulnerability to environmental degradation.
- High-populated OIC Member Countries like Indonesia, Pakistan, Bangladesh, Egypt and Turkey also face various serious environmental problems and challenges, such as water pollution from industrial sewage and cleaning chemicals and air pollution especially in urban areas due to heavy traffic and rising tourism industry.
- Therefore, to enhance their efforts towards sustainable development, there is an urgent need for the relevant authorities of the OIC member countries to give special attention and high priority to the

"Environmental Impact Assessment" as a tool to identify and mitigate potential environment impacts on their economies.

Dear Participants,

- The importance of the "Environmental Impact Assessment" process lies in its ability to predict, direct project studies and address environmental impacts before they occur. The "Environmental Impact Assessment" is an interdisciplinary process intended to inform the public and decision makers of the likely consequences of a proposed action in order to avoid or mitigate environmental degradation.
- It is worth mentioning here that the 4th Session of the Islamic Conference of Environment Ministers, which was held in Tunisia in 2010, made a declaration on "Enhancing the Efforts of the Islamic World towards Environment Protection and Sustainable Development". The Ministers agreed on promoting cooperation between the Islamic countries on issues pertaining to environment and sustainable development, within the framework of Islamic solidarity and joint Islamic action.
- In this connection, SESRIC has initiated the Environment Capacity Building Programme (Environment-CaB) in 2015 to contribute to the efforts of the OIC member countries towards enhancing the

technical capacities of their national institutions working in the domain of environment and climate change.

- Within the framework of this programme, we organise short-term training courses, training workshops (like this one), and study visits on a wide range of technical topics such as environmental risk assessment and early warning systems, environmental sensitivity mapping, diversification of agro-forestry and reforestation, etc. This is usually done through different modalities by matching the needs and capacities of the relevant national institutions working in the domain of environment and climate change.
- I believe that this training workshop, which aims at introducing the technical aspects related to the process of "Environmental Impact Assessment" and its procedures will contribute to enhancing the capacities of the participants through adding value and knowledge to their experience in this important area.
- Before concluding, I would like to thank you all once again and wish you a fruitful exchange of experiences and a successful training throughout the upcoming days.
