- SESRIC is hosting and managing the OIC Statistics Database (OICStat), the first and only international official statistics repository on the OIC MCs with more than 750 indicators under 24 categories including 85 indicators related to agriculture, water and environment. Furthermore, SESRIC assists member countries to develop and enhance capacities of their National Statistics Offices by organizing statistical training courses and workshops on agriculture, water and environment sectors.**
- SESRIC has achieved meaningful results by the successful implementation of many training and technical cooperation activities through its capacity building programs on agriculture, water and environment sectors. These programmes and activities provided a platform to the OIC MCs to work together and share their best practices and**

technical expertise with each other to attain higher socio-economic development.

In this context, Mr. Chairman, I would like to underline that our activities and programmes in the domain of agriculture, rural development, water and environment are well aligned with the goals of the 5-Year Action Plan of your Esteemed organization.
