The Government of Indonesia has received financing from the World Bank toward the cost of the *Statistical Capacity Building-Change and Reform for the Development of Statistics (STATCAP-CERDAS) Project*, and intends to apply part of the proceeds for consultant services of a reputed Statistical consulting firm (Consultant) in support of STATCAP-CERDAS Project implementation.

The Services are intended to provide technical assistance to BPS-Statistics Indonesia (Central Statistics Agency) in transforming the way statistical activities are undertaken within BPS by: (i) establishing a Business Framework and Architecture for the future operation of BPS statistical activities; (ii) defining and establishing corporate statistical infrastructure needed to support the future method of operation of statistical activities in BPS; (iii) redesigning and implementing selected statistical collections and compilations operating within the future BPS organization using the corporate statistical infrastructure to achieve improved integration, quality and efficiency; (iii) providing methods or advice for BPS to address specific issues for selected statistical collections and activities; and (iv) ensuring Human Resource and Organizational Alignment activities under the STATCAP-CERDAS Project meet the requirements for improving statistical activities. The BPS-Statistics Indonesia, as the implementing agency, now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide specific and sufficient information indicating that they are qualified to perform the services (at the minimum, expressions of interest should contain the following: a. information about the firm/organization, b. description of similar assignments, including scope, duration and value, c. experience in similar conditions, and d. availability of appropriate skills among staff).

Consultants are likely to have successfully delivered similar assignment providing advisory and technical assistance services in the implementation of large-scale official statistics reform and modernization programs, particularly in national statistical offices in developing countries. The successful Consultant should propose a team of full-time and part-time professionals, with a multi-year track record of successful delivery of similar assignments. Experience in the following area or tasks will be considered for these assignments: (i) improvement of organization and management of national statistical offices; (ii) improvement of statistical processes and methodologies; (iii) development of statistical infrastructure; (iv) redesign/reengineering of statistical operations and programs; (v) design and implementation of

applications and information systems for official statistics production; and (vi) capacity building and training in various areas of official statistics.

Consultants may associate to enhance their qualifications. If the consultants decide to express interest in the form of an association, they need to submit a letter of association or an MOU which should clearly indicate whether (i) the association is in the form of a joint-venture (JV) or sub consultancies, and (ii) in the case of a joint-venture association, the letter should explicitly state that the JV partners are jointly and severally liable for the assignments. Qualification documents should be submitted for each of the joint venture members. In addition, each consultant should specify in its submission whether it is a commercial firm or a non-profit organization.
