- The abstract has to be very precise and include objectives, design, main results and conclusions.
- The abstract should not contain more than 300 words except from the title, name of the author and address.
- The abstract has to be written in with Times New Roman 10 and 12 size letters for the text and the titles respectively.
- Names have to be written in miniscule only with the first letters in capital, without any abbreviations and typing size has to be 10. Author's place of work has to be indicated.
