

REPORT OF THE FORTY FIRST SESSION OF THE PERMANENT FINANCE COMMITTEE OF THE ORGANIZATION OF ISLAMIC COOPERATION

JEDDAH – KINGDOM OF SAUDI ARABIA 29 SHAWWAL – 02 ZUL QADAH 1433H (16-18 SEPTEMBER 2012)

- The Permanent Finance Committee (PFC) of the Organization of Islamic Cooperation held its Forty First session in Jeddah, Kingdom of Saudi Arabia from 29 Shawwal to 02 ZulQadah1433H (16-18September 2012).
- **2.** The Meeting was attended by the representatives of 39 Member States and of the General Secretariat and the Subsidiary Organs whose names are attached hereto (**Annex I**).
- **3.** The meeting was declared open by Mr. Bakyt Batyrshayev, Head of delegation of the republic of Kazakhstan and Permanent Representative to the OIC, as chairman of the 40th Session of the PFC.
- 4. The Meeting started with a recitation of verses from the Holy Quran.

6. His Excellency the Secretary General of the Organization of Islamic Cooperation, Prof. Dr. Ekmeleddin Ihsanoglu, delivered his statement (Annex II), in which he first welcomed the distinguished delegates and expressed that he has always been keen to attend the Committee's meetings given the importance that he attaches to its work and the implications of its decisions on the progress of this Organisation. While commending their dedication, the Secretary General thanked the Committee for all its past and present cooperation which has made significant strides in the areas of development and progress, thus, allowing him to achieve many of the goals ahead of us.

- 7. Highlighting the various initiatives and activities carried out in the General Secretariat towards implementation of the Ten Year Programme of Action in past eight years, the Secretary General confirmed that the growing activities and responsibilities of the Organisation has emphasized the need for an increase in the budget, but he has to take into account the negative effects brought about by the political and economic upheavals in some Member States, and by the massive economic crises that befell the global economy. The Secretary General emphasized that as the General Secretariat looks forward to new challenges and activities, it needs to increase next year's budget by 9.7%, to become \$32.03 million compared to the \$29.2 million of this year's budget; justifying the request for only the Programme Activities chapter as well as the needed budget for the OIC Independent Permanent Human Rights Commission. The Secretary General invited the Committee to consider it with more attention and to imagine the weight of the necessary responsibilities which have to be seriously undertaken if we want to raise the Organization to the level which we aspire to.
- 8. The Meeting was officiated by Amb. Dya-Eddin Bamakhorama of the Republic of Djibouti, in his capacity as the Chairman of the 41st Session of the PFC and head of the delegation of the Republic of Djibouti. Having declared the Session open, he welcomed the participants and expressed thanks to the Custodian of the Two Holy Mosques, King Abdullah Bin Abdelaziz and to the Government of the Kingdom of Saudi Arabia for their consistent support to the OIC, and wished the current Session complete success.

- **9.** The Committee approved its Agenda and Program of Work as submitted by the General Secretariat as in (Annex III).
- **10.** The Committee considered exhaustively the various agenda items of the meeting and, following in-depth discussions, decided the following:

The 33rdReport of the Finance Control Organ:

- 11. The Committee examined the 33rdReport of the Finance Control Organ concerning the closing of accounts of the General Secretariat and Subsidiary Organs for the fiscal year ending 31/12/2011, and the General Secretariat and Subsidiary Organs' replies to the Observations of the FCO.
- 12. Following in-depth discussions on the report and after listening to the replies and clarifications of the General Secretariat and its Subsidiary organs, the Committee adopted the 33rd FCO report with the replies of the General Secretariat (Annex IV) with the following recommendations:
 - The committee stressed the General Secretariat and its subsidiary organs to abide with the recommendation and observations of FCO in its 33rd reports pecially on:
 - i) To transfer the surplus resulting from an increase of resources over expenditures in the closing accounts of previous years to the reserve account.
 - ii) Contractuals shall not be given supervisory positions.
 - iii) Transfer between chapters by subsidiary organs without prior approval of the Secretary General.
 - 13. The committee strongly recommended the CFM to give a warning to subsidiary organs who fail to submit their documents at least two months before the starting of the PFC meeting.

General Secretariat Report on the OIC Financial Position of Arrears

14. The Committee took note of the efforts of the Secretary General on the recovery of arrears and called for continuation of the high level contacts and dialogue with Member States, including official communications to address this situation, while urging the defaulting members states to honor their financial obligations by settling their respective accumulated arrears to the General Secretariat and its subsidiary organs. The committee considered the Report on The OIC Financial Position of Arrears submitted by the General secretariat and approved Proposals of General Secretariat for Improving Collection Methods except the point on the applying of progressive measures to the defaulting member states out of respect for Islamic solidarity and cooperation.

Budgets of the OIC for the Financial Year 2013;

A) The Budget of the General Secretariat:

- 15. The Committee considered the proposed budget submitted by the General Secretariat for the Financial Year 2013 and, taking note of the interventions and exhaustive discussions by the various delegates as well as the clarifications and explanations presented by the General Secretariat, decided the following:
 - The adoption of the proposed draft budget of the General Secretariat for the Financial Year 2013 for a total amount of USD 30,062,600.00 (with an increase of 3.00%) over the ceiling of the budget of previous year 2012) as follows:

- 16. Regarding the establishment of new regional offices, the committee agreed that it is not in the position to take any decision on the matter and therefore agreed to suggest the estimated budget, prepared by the General secretariat, amounting to US\$1 million for opening two new offices to the forthcoming 39th CFM to be held in Djibouti for its decision.
- B) Budgets of the Subsidiary Organs:
- 17. The Committee decided that Subsidiary Organs shall submit all relevant documents to Member States at their respective capital and through the General Secretariat of OIC, for consideration of the annual sessions of the PFC at least two months before the date of the session. They can utilize such new means as electronic mails, etc.
- 18. After examining the proposed budgets of the Subsidiary Organs, the Committee recommended their adoption for the Financial Year 2013 as follows:

27. Report of the Third Session of the Inter-Governmental Group of Experts (IGGE) Meeting on the Amendments/Clarifications to the Personnel Regulations of the OIC.

The committee considered the report and the Amendments/Clarifications to the Personnel Regulations of the OIC and requested the 39th CFM to mandate an IGGE Meeting to further review the Amendments/Clarifications to the Personnel Regulations of the OIC, and submit its final version to the 42nd PFC.

28. Report of the Fourth Session of the Inter-Governmental Group of Experts (IGGE) Meeting on the Draft Financial Regulations for the OIC Humanitarian Affairs Department Field Operations.

The committee considered the report of the Inter-Governmental Group of Experts (IGGE) Meeting on the Draft Financial Regulations for the OIC Humanitarian Affairs Field Operations and decided to request the 39th CFM to mandate an Inter-Governmental Group of Experts (IGGE) to review a modified version of the document to be submitted by the General Secretariat, and to submit its findings to the 42nd PFC Session.

Any Other Business

Report of the Consultative Committee Meeting on the Study of the Programme-Based Budgeting in the UN System:

29. The Committee took note the explanation given by the General Secretariat (Annex VIII) and called the General Secretariat to conduct a further study and submit its findings to the 42ndPFC Session.

Reservations

30. Jordan submitted a reservation on its contribution to the OIC budget

The Hashemite Kingdom of Jordan reaffirms item 1 of resolution 2/31-AF adopted by the 31st Session of the Council of Foreign Ministers held from 14 to 16 June 2004, which approved the report of the 32nd Session of the Permanent Finance Committee held in Jeddah on 28-31 March 2004, containing the reservation of the Hashemite Kingdom of Jordan on the increase of its contributions to the budget of the OIC and its subsidiary organs.

Pursuant to Article 29-1 of the Charter of the Organization of Islamic Cooperation (OIC) which provides that contributions of Member States shall be determined in accordance with their GNP, and in line with a study prepared by the OIC's Statistical, economic and Social Research and Training Center (SESRIC) in Ankara which revealed that, according to Article 29-1 of the OIC Charter, the contribution of the Hashemite Kingdom of Jordan should be 0.588% and not 1%. Accordingly, Jordan is committed to paying its contribution to the budgets of the OIC and its subsidiary organs at the rate of 0.5888%, in accordance with the Charter.

Vote of Thanks

- **31.** The Committee expressed its gratitude to the Chairman and members of Finance Control Organ for their efforts in the preparation of the report of the FCO and for the auditing of the accounts of the General Secretariat and the Subsidiary Organs.
- **32.** At the close of its proceedings, the Chairman of the Committee expressed his profound thanks to all the participating delegations for their full cooperation and also addressed, on their behalf, sincere thanks and appreciation to H.E. the Secretary-General and to the officials of the General Secretariat for the excellent arrangements made and facilities provided for the smooth progress of work of the meeting.
- **33.** The committee expressed its deep appreciation to the Chairman for his excellent stewardship of its proceedings. The Committee also thanked members of the Bureau for their support and cooperation.
- 34. The Committee addressed a Cable of thanks and gratitude to the Custodian of the Two Holy Mosques, King Abcullah Bin Abdul Aziz Al Saud, King of the Kingdom of Saudi Arabia for his continuous support to the Organization. It also expressed its gratitude to the Government and people of the Kingdom of Saudi Arabia for their generous hospitality and warm reception accorded to all delegates.
